## Privacy Policy

### West Ohio Food Bank Privacy Policy

The West Ohio Food Bank shares your concerns about privacy on the Internet. In order to better protect your privacy, the West Ohio Food Bank has provided this notice explaining its online information practices and the choices you can make about the way your information is collected and used on the Site. On occasion, the West Ohio Food Bank may run promotions or conduct other activities with affiliate partners from this Site. In such event, we may post additional privacy terms in conjunction with such promotion or activities that modify and/or supplement this Privacy Policy and govern the use of information related to or received through such promotions or activities.

#### The West Ohio Food Bank's Collection and Use of Your Information

In the course of using the Site, the West Ohio Food Bank may ask you for your name, email address, postal address, telephone number, fax number, as well as other relevant information. The West Ohio Food Bank also may collect certain non-personally identifiable information when you visit many of our web pages such as the type of browser you are using (e.g., Netscape, Internet Explorer), the type of operating system you are using, (e.g., Windows 2000 or Mac OS), the domain name of your internet service provider (e.g., America Online Earthlink), aggregate data about the number of visits to the Site and/or aggregate data about pages visited.

#### How the West Ohio Food Bank Uses the Information

The West Ohio Food Bank uses the non-personally identifiable information ("Aggregate Data") to improve the design and content of the Site and to enable the West Ohio Food Bank to personalize your Internet experience. ## **Terms and Conditions of Use**

## **1. Introduction.**

Welcome to the web site ("Site") for West Ohio Food Bank.

## **2. Access to the Site.**

**BY ACCESSING, BROWSING AND /OR USING THE SITE, YOU ACKNOWLEDGE THAT YOU HAVE READ, UNDERSTOOD AND AGREED TO BE BOUND BY THESE TERMS AND CONDITIONS OF USE ("TERMS AND CONDITIONS OF USE") INCLUDING THE PRIVACY POLICY ("PRIVACY POLICY") [LINK], (COLLECTIVELY, THE "TERMS") AND TO COMPLY WITH ALL APPLICABLE U.S. LAWS AND REGULATIONS.** If you do not or cannot agree to the Terms, do not use the Site or any of the services offered through the Site. West Ohio Food Bank reserves the right, in its sole discretion, to update, revise, supplement and to otherwise modify these Terms, and to impose new or additional terms and conditions on your use of the Site from time to time. You agree that the parties shall settle any claim or dispute relating to these Terms by binding arbitration in Lima, Ohio under the Commercial Arbitration Rules of the American Arbitration Association. To the fullest extent permitted by applicable law, no arbitration under these Terms shall be joined to an arbitration involving any other party subject to these Terms, whether through class arbitration proceedings or otherwise. NOTWITHSTANDING THE DISPUTE RESOLUTION REQUIREMENTS SET FORTH ABOVE, FOR ANY INJUNCTIVE RELIEF RELATING TO YOUR ACCESS TO, OR USE OF, THE SITE INCLUDING, WITHOUT LIMITATION, RELATED SERVICES, YOU AGREE AND HEREBY SUBMIT TO THE EXCLUSIVE JURISDICTION AND VENUE OF THE APPROPRIATE STATE OR FEDERAL COURTS LOCATED IN ALLEN COUNTY, OHIO, U.S.A.
